What is the overall <u>Deductible</u>?	<p><u>Network</u>: \$4,000/Individual or \$8,000/Family per Calendar Year</p> <p><u>Out-of-Network</u>: \$4,000/Individual or \$8,000/Family per Calendar Year</p>	<p>Generally, you must pay all of the costs from <u>providers</u> up to the <u>Deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, they have to meet their own individual <u>Deductible</u> until the overall family <u>Deductible</u> has been met.</p>
Are there services covered before you meet your <u>Deductible</u>?	<p>Yes: <u>Preventive Care</u> services.</p>	<p>This <u>plan</u> covers some items and services even if you haven't yet met the annual <u>Deductible</u> amount. But a <u>Co-Payment</u> or <u>Coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive</u> services without <u>cost-sharing</u> and before you meet your <u>Deductible</u>. Are there other <u>Deductibles</u> for specific services?	<p>No.</p>	<p>You don't have to meet <u>Deductibles</u> for specific services.</p>
What is the <u>out-of-pocket limit</u> for this <u>plan</u>?	<p><u>Network</u>: \$5,500/Individual or \$11,000/Family per Calendar Year</p> <p><u>Out-of-Network</u>: \$11,000/Individual or \$22,000/Family per Calendar Year</p>	<p>The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u>, they have to meet their own individual <u>out-of-pocket limit</u> until the overall family <u>out-of-pocket limit</u> has been met.</p>
What is not included in the <u>out-of-pocket limit</u>?	<p>Ineligible charges, amounts over the <u>maximum allowable charge</u>, <u>premiums</u>, <u>balanced-billed</u> charges, and health care this <u>plan</u> doesn't cover.</p>	<p>Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u>.</p>

Important Questions	Answers	Why This Matters:
<p>Will you pay less if you use a <u>Network provider</u>?</p>	<p>Yes, see the back of your ID card for more information.</p>	<p>This <u>plan</u> uses a <u>Provider Network</u>. You will pay less if you use a <u>provider</u> in the <u>plan's Network</u>. You will pay the most if you use an <u>Out-of-Network provider</u>, and you might receive a bill from a <u>provider</u> for the difference between the <u>provider's charge</u> and what your <u>plan</u> pays (a <u>balance bill</u>). Be aware, your <u>Network provider</u> might use an <u>Out-of-Network provider</u> for some services (such as lab work). Check with your <u>provider</u> before you get services.</p>
<p>Do you need a <u>referral</u> to see a <u>specialist</u>?</p>	<p>No, you do not need a <u>referral</u> to see a <u>specialist</u>.</p>	<p>You can see the <u>specialist</u> you choose without a <u>referral</u>.</p>

This is not a cost estimator. Treatments shown are just examples of how this plan might cover medical care. Peg is Having a Baby
